If, after making a nomination, you marry, separate or divorce, enter a de facto relationship (including same sex), have a child, if someone you nominate has died, or someone becomes or is no longer financially dependent upon you or in an interdependency relationship with you, then you should review your nomination/s or consider making new nomination/s.
